MESSAGE FROM THE PRESIDENT - Marge Gaskins

The Legislature is underway, and the political disagreements have begun. Hopefully another year will not go by with that being the primary accomplishment. Certainly there are enough important issues needing consideration and thoughtful discussion to keep everybody busy before the electioneering begins.

Topping the list may be the 4-year term for Governor and Lt. Governor without spending a lot of time debating the inclusion of the legislators. If they don't vote on it this year, it cannot be considered again for at least 4 years. The League position is firmly in favor of this proposal, but there is no assurance that the bill will even make it through the committee. We may also see the government operations committee address campaign finance, with or without public funding, and IRV.

Other serious issues such as school funding, required civics education, voter registration on election-day, energy efficiency and costs, and health insurance for all will need some ideas and resolutions. Perhaps when everyone starts running for office, the hard questions will get asked, and maybe answered.

The Champlain Valley LWV must have the opportunity to address these issues with the candidates, perhaps with a voter's guide, forum or debate. If you have an interest in sharing your ideas and working on such possibilities, please let me know as soon as possible. We have no specific voter service committee appointed, but if this is your interest, let's get started.
